4. PARTICIPATION FEE

Participation fee 190 EUR
Participation fee for co-exhibitor 190 EUR

A non-refundable participation fee includes identity cards for participants, publication of the fair catalogue, one parking card for the whole fair period, general advertising expenses and administrative expenses.

The application for participation must be made on the official filled in application form sent to the Organiser by March 26, 2018, at the latest. Orders submitted after this deadline will be fulfilled, if possible.

5. EXHIBITION SPACE AND STANDARD STANDS

Indoor space only 25,00 EUR/m²

Indoor space includes general lighting, central heating, cleaning of the gangways and general security alarm system.

17...m² 15,00 EUR/m²

Standard stand rental includes elements for demarcation of the stand (walls and fascia elements), carpet, lighting units (1 per 4 sq. m).

Outdoor space 15, EUR/m²

All prices include VAT.

6. FAIR SERVICES

In order to apply for fair services, the Exhibitor must complete the relevant forms for the fair services which must be submitted to the Organiser by April 01, 2018, at the latest. Orders submitted after this deadline will be satisfied according to the possibilities.

If the Exhibitor chooses to construct the stand through individual means and materials, the intended layout of the stand must be submitted to the Organiser by April 01, 2018, in accordance with the prescribed fire-precautions and labour protection rules. Exhibitor should mount and dismantle his stand within the time limits prescribed by the Organiser. If the stand will be designed or constructed not by the Exhibitor but some other parties, the Exhibitor is committed to inform the Organiser about the name and contact data of the named party.

Removal of exhibits: April 22 4 p.m. to 8 p.m

April 23 9 a.m. to 6 p.m

For working in the pavilions outside the fair timetable extra 105 EUR per hour will be charged.

7. IDENTITY CARDS

In proportion of the rented exhibition space identity cards will be issued to the Exhibitor at the info stand on April 20, 2018, as follows:

up to 20 sq. m. – 5 cards
21 – 45 sq. m. – 8 cards
over 45 sq. m. – 10 cards.

8. PARKING

The Exhibitor will receive one free parking card for the whole fair period. Extra parking cards are available at the info stand (9 EUR, for the period) and at the entrance of the fair territory (3 EUR, single entry).

9. FAIR CATALOGUE

Data on participating companies and organisations, submitted to the Organiser by April 01, 2018, at the latest, will be published in the fair catalogue free of charge.

10. USE OF THE TRADEMARK

The Exhibitor is allowed to use the fair trademark in its own advertising and commercial activity only in accordance with the Organisers.

11. TERMS OF PAYMENT

Confirmation for participation at the Fair and invoice for the participation fee, rental for exhibition space or exhibitions stand and fair services will be sent to the Exhibitor after receiving and accepting the properly filled in application form.

The Organiser will charge 50% extra of the price list for orders of constructions and fair services placed by Exhibitor during the fair (April 20 - 25, 2017).

If the Exhibitor has not made the payments by the exposition layout day - April 19, 2018, the Organiser reserves the right to use the stand as he sees fit.

All payments for additional fair services placed during the exhibition layout or exposing period should be paid in cash during the fair or remitted to the Organiser's bank account in 15 days after the closing of the fair according to the invoice sent to the Exhibitor .

12. TERMINATING THE CONTRACT

The exhibitors are entitled to cancel all reservations bearing no sanctions prior March 01, 2018. Cancellations made between March 02 and March 21, 2018, are subject to 50% of any charges already fallen due. Reservations cancelled after March 22, 2018, are subject to any charges.
